Electronics

- Any products required to be approved under the FCC equipment authorization program that have not been so authorized and labeled, such as
 - LED signs that have not been tested to demonstrate compliance with the FCC's emissions limits
 - Wireless communications devices that must be certified by the FCC and be labelled with an FCC I.D. number.
- Any devices that replace or modify the existing technology in a device without being properly authorized as required under FCC rules, such as
 - Devices that replace or modify technical components in a video game or game console
 - Devices that change or allow the user to change the frequency or frequencies in an existing product
- Any devices operating on unauthorized frequencies, such as
 - Fishing net buoys operating on radio frequencies assigned to Automatic Identification Systems (AIS))
 - Drones operating on frequencies that are reserved for Federal Government use.
- Jammers of any kind, including devices that interfere with cell, GPS, radar, or WiFi signals
- Any devices that detect or interfere with law enforcement or public safety equipment, such as
 - Devices that detect police cameras, sensors, or similar equipment
 - Products designed to affect the operation of traffic signals or block detection by red light cameras
- Software, hardware and devices (e.g., books) that enable the circumvention of copy-protected digital products, such as:
 - Boot disks, cards, emulators, or loaders
 - Import converters
 - Satellite and cable TV descramblers
 - DVD duplicators that circumvent protections against copyright infringement
 - Blu-ray players altered to disable region coding
- Power amplifiers compatible with CB radios
- Impermissible cell phone devices, such as
 - Cell phone unlocking devices
 - Jailbroken cell phones

Food

- Expired food
- Non-DSV items that require refrigeration (Note* - Refrigerated DSV items subject to approval)
- Product subject to Recall.
- Products deemed adulterated, misbranded, unsafe, and/or otherwise prohibited from sale by the FDA, USDA (United States Department of Agriculture), or other governing regulatory agency.
- Unpasteurized soft cheeses.

Hazardous

- Products prohibited from sale by the EPA or other regulatory agency due to its hazardous status
- Explosives
- Radioactive or contaminated material

Illegal

- Any products encouraging or enabling illegal activity
- Any products that violate applicable laws
- Any products that contain viruses, trojan horses, spyware or malicious code
- Stolen or counterfeit products

Intellectual Property

- Products that violate or infringe upon any intellectual property right or other third-party right

Lasers

- Class IIIB, Class IV lasers

Offensive

- Products marketed to or targeted at kids or teenagers that are age-inappropriate
- Products that contain obscene material or pornography
- Products that display explicit nudity or vulgar language
- Products that either portray, glorify or promote in an insensitive way: animal cruelty; any historical or news events; criminal or illegal activity; derogatory stereotyping based on race, ethnicity, gender, sexual orientation, religion, or nationality; hatred; intolerance; natural or man-made disaster(s); tragedy; violence

Plants, Plant Products, Seeds

- Illegal plants, plant products, or seeds
- Plants, plant products, or seeds subject to federal, state, or local government quarantine or other restriction
- Plants, plant products, or seeds that are considered to be a controlled substance

Tobacco

- Cigars
- Cigarettes
- E-cigarettes
- Other tobacco/nicotine containing products

Unsafe Products

- Recalled products
- Candles with metal core wick
- Natural feather boas
- Novelty lighters
- Sky lanterns
- Tube-kites / flying water rafts
- Water walking ball
- Yoyo waterball

Weapons

- "Slasher" knives or other devices used in cockfighting
- Airguns, BB guns, pellet guns that use gunpowder or are > .25 cal
- Airsoft or replica firearms that don't have permanent blaze orange barrel marking or a blaze orange barrel plug
- Any weapon designed to be concealed
- Axes or machetes marketed as weapons that are not purely ornamental (e.g., have sharpened edges), and are not designed for home improvement, hunting, camping, or other recreational use.
- Badge patches
- Badges encased in Lucite
- Badges, credentials, and/or identification cards (including reproduction of such) from any law enforcement agency, government agency, or private security company
- Balisong knives
- Barrel shroud
- Baseball bats or other sporting goods marketed for self-defense purposes
- Bayonets designed to fit an assault weapon
- Blank or dummy ammunition
- Blueprints, milling or forging specifications for assault weapons
- Brass knuckles, including those made from other materials
- Bullets, buck shot, or lead shot
- Butterfly knives
- Cartridges, casings, shells, or hulls
- Claws or spikes that attach to the shoe, foot, or other body parts
- Concealed weapons permit or licensed gun permit badges
- Dart guns
- Disguised stun guns

- Dual-action or automatic knives
- Explosive
- Firearms regardless of their ability to fire, how old they are, or their status as collectibles; Firearm frames, including grip frames, muzzleloader and black powder frames or receivers; Firearm kits used to create a firearm; Firearm receivers, including upper or lower, incomplete, "cut" or "80%" receivers
- Fireworks
- Flash suppressors
- Forward pistol grip
- Gravity knives
- Grenades and grenade launchers
- Gunpowder or primers
- Handgun clips and magazines of any capacity
- Hidden or disguised knives such as air gauge knives, belt buckle knives, lipstick case knives, or writing pen knives
- High capacity magazines modified to accept 10 rounds or less unless permanently modified by the manufacturer
- High capacity magazines that accept more than 10 rounds are Not Permitted (some states may have a lower capacity limit)
- Inert ammunition
- Instructions or blueprints on how to convert a semiautomatic weapon to a fully automatic weapon
- Knives with raised knuckle guards or knuckle dusters
- Kunsari-fundo (also known as manrikis)
- Land mines
- Leaded canes, crutches, staffs, or sticks
- Magazine extenders
- Mini TSA badges
- Movie prop badges
- Nightsticks, billy clubs, billysticks, war clubs, war hammers, batons, PR 24s, Monadnock batons, ASPs, tonfas, truncheons, escrima sticks, paddy wackers, batons, sjamboks, weighted clubs and similar items
- Nunchakus (also called nunchucks or numchuks), chain sticks, or two-section staffs
- Out-the-front (OTF), sliding, or telescoping knives
- Paintball cannons or air cannons
- Paratrooper knives
- Parts or accessories for assault weapons, or any item that mentions capability with assault weapons, even if the part/accessory fits non-assault weapons
- Pin fire guns
- Pistol conversion kits that make a pistol into a shortbarreled rifle
- Powerheads, stick guns, or their equivalents

- Projectile/concussive devices that use gunpowder/explosives
- Push knives — also called push daggers, punch daggers, punch knives, push dirks, and T-handled knives
- Quasi-law enforcement badges such as fire department badges
- Quick reload clips or magazines
- Replica guns that were made by converting real guns, even if they can't be converted back to a working gun
- Replica or imitation switchblades
- Rifle clips and magazines of any capacity
- Sansetsukon or three-section staffs
- Saps, sand clubs, sandbags, slung shots, or blackjacks
- Sears
- Shobi-zue
- Shuriken, throwing stars, cyclone knives, Batman symbols designed for throwing
- Silencers and silencers for airsoft guns or other replica gun
- Smoke grenades
- Special event badges like inauguration badges
- Spring-assisted knives
- Starter pistols or blank guns, regardless of their markings
- Stiletto knives
- Stun batons
- Switchblade knives (knives with a blade that open automatically—for example, by pressing a button or through inertia or gravity)
- Sword canes and swordsticks
- Swords that are not purely ornamental or are marketed as ready for use as a weapon (e.g., "battle-ready"; "fully sharpened"; "sharpened to a murderous point")
- Tannerite
- Tear gas
- Throwing stars, ninja stars, throwing cards, Batman symbols, or Cyclone knives
- Zip guns
- Zoobox (also known as clackers or kung fu sticks)
