INTRODUCTION

This document contains an overview of the new features, fixes and changes included in version 1.8.2 of Business Cloud Essentials.

The key features and enhancements are:

- Addition of New domain CRM
- CRM Dashboard
- Sample Report Current Stock valuation
- Additional fields added to Domains

FEATURES

CUSTOM REPORTS - ADDITION OF CRM DOMAIN

A new CRM reporting domain has been introduced. This extends the range of data domains in BCE and is accessible relative to the BCE user permissions.

The following data sets are included in the CRM domain to allow users to create and build their own custom reports.

- Support Ticket Set Includes fields for Support ticket document and includes:
 - Billing Details
 - o Repair Order
- Contacts Lists all contacts details
- Opportunity Includes opportunity and custom fields
- Complaint Lists all complaints details
- Events Lists all events details

CRM DASHBOARD

Sample CRM dashboards containing four 'dashlets' are included on 'My Dashboards' > CRM. Dashboard. The CRM dashboard displays data for the calendar year.

 Opportunity Chance – This shows a count of opportunities falling within the range of opportunity conversion. There are options from this dashlet to show 'Opportunity by status'.
 Clicking any range updates the 'Opportunity by Status' to opportunity counts by their status within the respective range



- Opportunity by Status This shows a count of opportunities belonging to the respective status. A drill through is available from this dashlet to open the 'Opportunity Summary Report' in separate tab
- Opportunity Value Status wise This is represented in cross tab and displays the status and range of opportunities with opportunity value
- Priority Complaints This shows a count of complaints by month distributed within the respective priority. A drill through report is available from this dashlet to show more detailed complaint information

SAMPLE REPORTS

A 'Current Stock Valuation' report is provided as sample repository report. This report is created from the stock domain using the stock and stock location data sets.

This report shows the current valuation of stock by location.

The report includes additional fields to the standard BCE stock valuation report, for example, 'Stock code' and stock 'Last moved date'.
