FEATURES

CUSTOM DOCUMENTS – MANAGEMENT

Custom Documents is introduced permitting users to design and create their own customised document templates for printing documents from BCE.

A set of standard templates is provided by Advanced and these can be used or copied as required.

New templates can be created from scratch or copies of the standard templates can be modified using a document editor to create new template forms to your required format and corporate branding requirements.

An introductory video and supporting documentation is available describing how to enable and access Custom Documents from BCE and providing general guidance on the creation of templates using the document editor features.

IMPORTING EVENTS WITH CUSTOM FIELDS

Events can be imported from the Events "Actions" button and the option to import Events has been extended to support custom fields.



Import Preview

Any Custom Fields that have been defined for Events will be included on the import template header when clicking on the 'DOWNLOAD TEMPLATE CSV' button.

Before importing an opportunity file, a preview screen will be displayed showing the status of the records to be imported.

EXPORT COLUMNS FOR SUPPLIER & CUSTOMER

When exporting Customer and Supplier account records the 'Country Code' and 'Country Name' which were previously exported as a combined fields are now exported as two separate columns using the following headings:
