<b>HBCE-14129</b>	<b>Submitting Purchase Invoice – System Error</b>
Problem:	When submitting purchase invoices originating from purchase orders or goods received notes the system was found to return a system error.
Solution:	Modified the purchase order/goods received note search routines to ensure purchase invoices are submitted correctly.
<b>HBCE-14144</b>	<b>Purchase Order Dates - Purchase Order Custom Documents</b>
Problem:	Where the print and send functionality was used to send custom documents for purchase orders by email, the document date was missing from PDF attachments.
Solution:	Corrected the method of document creation when emailing custom documents.
<b>HBCE-14158</b>	<b>Purchase Order Document Date - Print Preview and Email</b>
Problem:	When printing previously stored purchase orders, the print preview and email attachments incorrectly displayed the document date as todays date.
Solution:	Modified the purchase order preview and attachment dates to respect the original document date.
