Development of DRS Version 6.1.9 is now complete and was released in February 2024.

DRS 6.1.9 is a minor patch, Following the Release of 6.1.8 a small number of Critical issues were discovered which are addressed in this patch.

What's new

This section describes the new or improved features we have introduced in this release and key fixes and improvements.

A closer look

This section provides extended information on key features and fixes

Fixes

DRS-7779 can't connect to DRS UI after upgrade from 6.1.7 to 6.1.8

After upgrading from 6.1.7 to 6.1.8 customers were facing an issue where they would be presented with an error when trying to log on.

This was due to an error in the controllerDirective XML when the key “customaction” was used, this resulted in an error and stopped the UI from loading correctly.

This has now been resolved.

DRS-7780 Manual Assignment error message - Unexpected Message when setting YES to lock the time

When attempting to manually appoint an appointment users were getting an Unexpected error message.

This was due to an issue with currentAssignment not being added for new locked jobs. This has now been fixed.

DRS-7781 OrderUpdates clear SOR descriptions cause problems on MobileGateway getSchedule

When processing an OrderUpdate via the Mobile gateway the SOR descriptions were being lost.

This was because when altering the data only the opt_sor_template table was checked for a description and if nothing was found it was left blank.

This has now been updated so that if the descriptions in s_sorcode are empty then it will look up the descriptions from the relevant SOR template in opt_pp_sor_template.

This resolve the issue and descriptions should be maintained for SORs after any creation or update.
