DRS 6.0.0.2 Summary

Release 6.0.0.2 includes a number of important changes since 6.0.0.1.

Purpose of this Document

This document is a detail of the functional changes made to DRS 6 since Release 6.0.0.1. It is intended for use by Advanced staff and our Version 6 Customers who require this detailed level of information when they are upgrading to 6.0.0.2.

DRS On Demand Client and DRS Business Layer

Problem with Change Assignment popup (DRS-4971)

A problem was found where attempting to change the assignment of a Planned job was met with an error stating that rescheduling was not possible for Non-Planned jobs. This has now been resolved.

View Sorting is not being applied (DRS-5094)

Default view sorting was not being applied when a view was selected from the dropdown. All Views will now be refreshed to properly react to the sort applied.

Advanced Filter constantly errors (DRS-5095)

An error was found where by entering any values into the Advanced Filtering would result in Views showing no data and a SQL error being displayed. This has been resolved.

Export file uses a semi-colon for separator not a comma (DRS-5096)

The delimiter value is a configurable value within opt_property. This is now set to a comma by default.

Internal Error when using Drag and Drop (DRS-5136)

An 'Internal Error' message was displayed when the SCHEDULE NOW button was clicked after using drag and drop. This has been resolved.

Screen Refresh on Data Change and Selection (DRS-3715)

A new screen refresh function has been implemented to ensure that when changes are made to the Object, DRS will display this detail fully without the user needing to refresh manually.

Worker details display is not displayed well (DRS-3711)

Various changes have been made to the WORKER object section on the Object Selector modal to ensure it displays correctly.

Progress bar shows overall status and not the actual progress of the action (DRS-3746)

The progress bar on Imports or Bulk Changes will now track based on the percentage completed rather than time remaining.

First Slot on a Monday does not show correctly (DRS-3774)

With First Slot on Monday selected, the diaries were not displaying with Monday as the start day. This was due to an incorrect Boolean flag. This has been corrected.

Sector Detail on Worker View is not displayed well (DRS-4111)

The Sector display on the Worker details screen has been updated to improve readability.

Locked worker on Job view (DRS-4183)

The Worker Lock icon has been updated to be responsive on hover over.

Add an option in the diary config to enable nightly mode (DRS-4337)

When DRS is configured to use Nightly Shifts, a new checkbox will be displayed on the diary configuration to set this view. It will be enabled by default.

Lock job popup is displayed inconsistent (DRS-4819)

The Lock Screen function is now more consistent.

Ability ID's are not shown in Combo Boxes for Worker Detail (DRS-4823)

The ID for the Ability Criteria was being displayed in the combo box dropdown when selecting options from the Worker Template within a Job Template. The Name now will be displayed instead.

"Back Button" disappears when "bookmarks" is unchecked under user interface in profile and enable learning mode is on. (DRS-4840)

This will now remain on the screen regardless of the button or option display configuration

More details are required when Temporary Abilities are configured (DRS-4859)

An additional panel of information has been added to the Ability configuration screens that will display any temporary ability configurations configured. This will include dates and times.

We should not be able to choose a default language which is not in Authorised languages (DRS-4862)

The ability to select un-authorised language packs was reported. This has now been resolved and only authorised language packs can now be selected.

When modifying available and default languages it's only applied after re-logging (DRS-4863)

Configuration changes require a log out to be applied in the main. An error will now be displayed alerting the user to Log Out and Log In again.

Add check to make sure at least one profile has Administrator Privileges (DRS-4923)

It was possible to uncheck Admin from the Global Privileges screen for all user profiles. This would result in no user having the ability to make Admin changes to the application. A change has been made to ensure that at least one user profile must be configured as an Administrator profile within the solution.

Internal error on Worker export (DRS-4956)

An error was found when trying to export the Worker details from the Import/Export tab. This has been resolved.

Configuration External charts (DRS-4964)

Several issues have been resolved related to the configuration of External Charts on the Home Screen.

Using h for Hour Filter does not work in V6 (DRS-5004)

h has been added as a filtering option within the view screens. This will allow you to filter for time ranges as a function of the time value in the column.

Order templates - Various issues found during testing (DRS-5044)

Several issues in action and display were found with the Order Template configuration screens. These have been fixed.

Suspended jobs are adding twice in diary bookmarks cart (DRS-5081)

When jobs were being suspended from the diary, where these jobs already existed within the Bookmark list, the jobs were added again, creating a duplicate. A check will now be made if the Job ID exists with the same User ID before it is added again.

Resource request on worker can be 0 minutes (DRS-5106)

When creating a worker request, the default duration could not be blank, but could be set to 0. This has been resolved and now needs to be greater than 0.

Date/Time business data does not save when first selected (DRS-5128)

When saving date/time objects, settings were not being saved if they were different from the default values. This has now been resolved.

Contract Management - Various issues found during testing (DRS-5135)

Various issues were found with the Contract Management screen. These have been resolved.

Hide Unavailable Days shows incorrectly when you use the back button (DRS-5164)

When navigating away from the diary with the HIDE UNAVAILABLE DAYS option selected, this was not respected when using the back button to return. This will now default always to the SHOW UNAVAILABLE DAYS regardless of the action used to display the diaries.

Worker Template has various errors (DRS-5165)

The Worker Template has had various issues resolved.

Editing a sub list twice results in the second selection not being registered (DRS-5169)

When editing Sub Lists and saving, it was not possible to edit again unless the screen was refreshed. This has now been resolved.



Utility Service

Contract Maintenance in Active Messaging is displayed incorrectly (DRS-4530)

The Contract Management screen of Active Messaging was poorly formatted and not in line with the main Active Messaging screen. This has been resolved.

Birt Runsheets

Remove XMBRACE word from Runsheet title (DRS-5023)

The XMBRACE branding has now been removed from the RunSheet format.
