## DRS 6.0.1.5 Summary

Release 6.0.1.5 includes a number of important changes since 6.0.1.4

### Purpose of this Document

This document is a detail of the functional changes made to DRS 6 since Release 6.0.1.4. It is intended for use by Advanced staff and our Version 6 Customers who require this detailed level of information when they are upgrading to 6.0.1.5.



## Summary

This document describes the functional changes made to DRS since Release 6.0.1.4

## DRS User Interface

The following changes have been made to the User Interface for DRS 6.

## DRS User Actions

The following changes have been made to the User Actions within DRS 6.

### Job Creation failing with too large a quantity (DRS-6450)

When determining the SMV for jobs an issue occurred where a default minimum of 30 was being put into the value before calculating the actual duration based on SMV \* Quantity. This resulted in the quantity being incorrect multiplied resulting in overly large values.

This has now been corrected back so that calculations are correct, however this means that the smallest value can be less than 30 minutes if the quantity assigned is lower than 30.

### Agency not pulled through to Job when adding job within an order (DRS-6484)

when trying to add a Job from within an Order, the Agency isn't pulled through to the Job and it cannot be selected. The user is then presented with an error when trying to continue.

this has been resolved and the agency will now correctly flow through the system into the new job.

## DRS Application Layer

The following changes have been made to the DRS Application, Server, or Database.

### Remove/UpdateLog4j (DRS-6472)

Although not strictly vulnerable to the issues log4j faced in the last year the library in use was outdated and required updating to a maintained version or removing to head off any potential further security issues.

The approach taken to use branch of Log4j that is internally maintained named AdvancedLogger. Whilst based on log4j this is a distinct version and has had all known vulnerabilities addressed.
