VERIFICATION

What is verification?



Nyack College is required by law to compare the information on your FAFSA application with the information provided on the verification worksheet and copies of your:

- W-2(s)
- Your IRS Tax Return or transcript
 - parent(s) if you are considered dependent
 - your spouse's if you are married

If there are discrepancies between your application and the documents you've submitted, corrections may need to be made and the amount of aid could change.

WHAT DO I DO?



Collect

- Tax returns and
- W2's required of
 - yourself
 - your parent(s)
 - Spouses

Or Non-filers application if taxes were not filed



Complete all the sections of the verification worksheet that apply

Sign the worksheet



For your security

Upload the completed worksheet and requested documents to the student portal.



Nyack College will compare the information on the documents to your FAFSA.

You will be informed if any further information will be required.



Email Nyacksfs.edu from your Nyack email address after uploading the documents so they can be reviewed and approved.

THE TAX RETURN WILL BE REJECTED IF IT IS NOT SIGNED

The Tax Return must have the

- Taxpayer signature or
- The Tax Preparer's PTIN




HOW DO I KNOW WHAT DOCUMENTS I NEED?

To view your documents, follow these steps:

- •Go to the my.nyack.edu website
- ·Sign in with your Nyack email
- Click on Student Portal
- Click on My Documents
- Click on Document Center
